

TL;DR - BHC Q2 MEETING SUMMARY (MAY 8, 2025)

News

• Lori Fleming is stepping down as BHC lead after over 15 years in the field. Deep appreciation was shared for her visionary leadership and collaborative impact.

Funding Updates

- 2024 opioid funds came in lower than expected: \$52,681 instead of \$58,641.
- Reprint of yellow resource cards planned before Lori departs.

Funding Landscape Triage

- Padlet tool launched to gather county-wide program impacts from state, federal, and private funding shifts. The resulting overview, which includes updates through 5/19/2025, will be shared with BHAC and County Housing Funding Board and can be viewed here.
- Key findings:
 - **Bayside Housing**: >40% cut, shelter staff at risk.
 - Recovery Café: 18% projected budget reduction.
 - Multiple programs facing funding uncertainty (EMS, home visiting, naloxone access, HUD).

Urban Rest Stop (URS) Concept

- Introduced by Commissioner Heather Dudley-Nollette.
- Originated from community input, especially **Maggie** (consumer advocate).
- Potential sites include Mountain View Commons, community centers, and more.
- Emphasis on hygiene access, geographic equity, and collaborative design.
- Still exploratory, but strong cross-sector support.

Governance & What's Next

- BHC–BHAC MOU still in process (delays due to staffing).
- Governance materials mostly ready but awaiting MOU alignment.
- Short survey coming to gather feedback on BHC's future structure and focus.

Opening and Transition Announcement

- Commissioner Heather Dudley-Nollette announced that Lori Fleming, long-time leader and convener of the BHC, will be stepping down.
- Acknowledgements of Lori's contributions came from several members, notably Apple Martine (JCPH) and Jim Novelli (DBH), emphasizing Lori's strategic leadership, system thinking, and ability to translate complexity into clarity.
- There was shared acknowledgment that Lori's departure marks a significant transition, but also an opportunity to evolve the BHC model.

2. Current Funding Overview & Budget Realities

- The 2024 Opioid Settlement disbursement was \$52,681, falling short of the expected \$58,641 due to a complex early payment and administrative fee adjustments.
- Questions were raised about the SBH-ASO's 10% admin fee, whether unused portions would be returned, and how to get clarity on these distributions.
- Lori suggested reprinting the yellow resource cards before departure, with potential small funds available to do so.

3. Shared Accomplishments Recap

Since 2018, the BHC has:

- Secured over **\$1.3 million** in collaborative funding.
- Supported program launches: Recovery Café, The Nest, Pfeiffer/Parliament Houses, CARES.



- Progressed Phase 2 Governance: Vision, Mission, Strategy finalized; Fist-to-Five voting model drafted.
- Initiated systemwide data alignment discussions and drafted a BHC-BHAC MOU for transparency and coordination.
- 4. Funding Landscape: Triage Exercise
- Participants were asked to contribute to a **Padlet** capturing impacts of funding shifts across programs. This effort is intended to inform collaborative decision-making.
- Commissioner Dudley-Nollette committed to helping gather responses from unrepresented agencies (e.g., Therapeutic Courts, housing providers).

Highlights from Triage Table (See Table, which includes updates through 5/19/2025):

- **Bayside Housing** faces a >40% loss in funding.
- Recovery Café anticipates an 18% budget reduction.
- EMS, Harm Reduction, Home Visiting, HUD and others flagged uncertainties and upcoming risks.
- Broad consensus that shared advocacy, funding coordination, and gap-filling collaboration are needed.

5. Urban Rest Stop (URS) Concept Presentation

Commissioner Heather Dudley-Nollette presented an overview of URS development efforts:

- Originated from community member Maggie, a recovery advocate and person with lived experience.
- April meeting included reps from JCPH, OlyCAP, DBH, Dove House, and others (full details in separate URS notes document).
- Key needs identified: hygiene, storage, case management access, geographic equity, pet support, food services.
- **Proposals reviewed**: Former Yacht Club, Mountain View Commons, community centers in Quilcene/Brinnon, Haines St. Cottages, Caswell-Brown site, school health center model.
- Tools were drafted (by Lori) to evaluate site options—feature summary tables, quick comparison grids, mini-assessment forms.
- The URS initiative is still **exploratory**, with strong support noted from BHC members. Emphasis placed on honoring consumer voice and designing services that reflect real needs.



6. Governance, MOU, and Looking Ahead

- The **BHC-BHAC MOU** is in process. Apple Martine shared that while progress has slowed due to staffing gaps, subcommittee meetings are planned ahead of the June BHAC meeting.
- Finalized governance materials are housed online and ready for ratification once the MOU is settled.
- A **short survey** will be sent to BHC members to gather input on the future of the table, including what elements should evolve, continue, or be reimagined.

7. Closing Remarks

- Lori closed the meeting by expressing deep gratitude and trust in the resilience of the BHC table.
- She shared a metaphor of the **BHC as a mushroom network**—the visible work may shift, but the **mycelium of trust, collaboration, and care** continues beneath the surface.
- Heather and others affirmed that next steps will be co-designed with BHC members and that a transition strategy is being developed.
